## RESULTS

### Defense Verdict for Moving Truck Rental Company

#### **Trucking & Transportation Liability**

**February 16, 2024**

We secured a jury defense verdict in a general liability lawsuit brought against our client, a Pennsylvania moving equipment rental company. The plaintiffs were in their car at a McDonald's drive-thru in Delaware when their vehicle was struck by an unattached trailer that had blown from an adjacent parking lot during a storm. The trailer was blown from the parking lot of the adjacent gas station which rented trailers to the public as part of a dealership agreement with a Delaware moving equipment rental company that had the same parent corporation as the client.

#### **Asbestos and Mass Tort Litigation**

**March 26, 2020**

Kevin Hexstall and Mohamed Bakry (Philadelphia) successfully litigated a complex asbestos case, obtaining a non-suit on behalf of their client, a manufacturer of asbestos-containing building materials. The case involved a deceased 71-year-old mesothelioma plaintiff. There was an initial seven-figure dollar demand from plaintiff's counsel. The lawsuit alleged the plaintiff was exposed to asbestos when employed as a construction product salesman from 1967 to 1972.

### Truck Driver Exonerated from Criminal Charges in Aggravated Assault by Motor Vehicle Case

#### **Trucking & Transportation Liability**

**January 22, 2016**

Obtained a defense verdict in an aggravated assault by motor vehicle trial held in the Court of Common Pleas of Lehigh County. The truck driver client was involved in a serious accident with a passenger vehicle. He was approaching a red traffic signal when he realized that he could not apply the brakes in time to stop the tractor-trailer without jack-knifing. He activated his air horn in an attempt to notify other drivers at the intersection that he was unable to stop. There were two vehicles on either side of the intersection. One of those drivers was a 19-year-old
